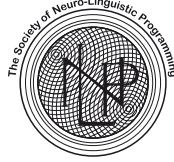

CERTIFICATION AND LICENSE AGREEMENT

MASTER TRAINER

in the Art of Neuro-Linguistic Programming

This Agreement is made this () day of () 20 (), by and between
The Society of Neuro-Linguistic Programming & The NLP Connection (the Licensor)
and

(the Licensee)

This Agreement is made with reference to the following facts, and it is hereby agreed as follows:

1. The Licensor hereby certifies that the Licensee has received the necessary training and has demonstrated the required skill in the art and techniques of Neuro-Linguistic Programming to qualify as a **Certified Master Trainer in the Art of NLP**. The Licensee hereby agrees to abide by and follow the rules and regulations in connection with this certification.
2. The Licensor has provided the Licensee training and testing represented by the Certification granted herein; and will renew such Certification under the terms and conditions set forth in this agreement.
3. The purposes of this Agreement are to protect the rights of the Licensor in maintaining the high quality and proper use of the techniques of NLP; and to outline the rights and obligations of the Licensee arising by virtue of the Certification and License granted hereby.
4. The term of this Certification shall be for a period of three years from the date hereof, subject to renewal for successive three-year periods, unless otherwise revoked or terminated by reason of any of the events described in Paragraph 9 of this agreement.
5. During the term of this Certification, or any renewal thereof, the Licensee shall be entitled to represent to others that he/she is so certified as a **Master Trainer in the Art of Neuro-**

Linguistic Programming by the Licensor for the purposes of teaching and demonstrating the skills which the Licensee has acquired.

6. The Licensor shall not be responsible or liable for the Licensee's personal conduct or operations, utilizing the training, techniques and skills which the Licensee has acquired; and the Licensee agrees to hold harmless the Licensor from any and all claims of any nature arising out of the Licensee's acts or conduct. It is further understood and agreed that this Agreement does not create any partnership, employment, or agency relationship between the parties hereto.
7. The Licensor hereby grants to the Licensee the non-exclusive right to use the official seal of the Society of Neuro-Linguistic Programming (Service Mark), which is awarded with this certification for the purpose of informing others that the Licensee has been certified in the art and techniques of NLP. Only Trainers can use the Society Seal (Service Mark) on the covers of their brochures or announcements. It is expressly understood and agreed that the Licensee is not being granted any proprietary right, title, or interest in the Society Seal (Service Mark), or any registration thereof
8. The Certification granted herein are personal in nature and shall not be transferable or assignable by the Licensee.
9. In addition to the natural expiration of the term of this Certification and License granted herein, this Agreement and certification, and rights granted shall be subject to termination, at the option of the Licensor, as a result of any of the following events:
 - A. The Licensee intentionally misrepresents or uses any of the skills and techniques involved in Neuro-Linguistic Programming for the purpose of defrauding others;
 - B. The Licensee attempts to transfer or assign the Certification and/or License granted herein;
 - C. The Licensee breaches any term or provision of this Agreement.

In the event of such occurrence, the Licensor may terminate this Agreement and revoke all rights granted herein by delivering to the Licensee a written Notice of Termination specifying the particular grounds for such action. Termination shall become effective as of ten days after said Notice was deposited in the mail or was personally delivered to the Licensee. Upon termination, the Licensee shall immediately discontinue all use of the Society Seal (Service Mark) on all documents and stop representing to others that he/she is certified by the Licensor in the art and techniques of NLP.

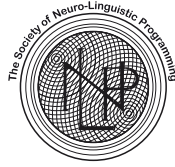
