Requirements for Certification MASTER TRAINER in the Art of Neuro-Linguistic Programming

If you have already been certified as a NLP Trainer through the Society of NLP in association with Dr. Doris A. Greenwood or Christina Hall, Ph.D., and you are interested in the continued expansion and refinement of your training skills, you are eligible for certification as a NLP Master Trainer. You may also qualify if you have a valid minimum of 12 Day TT certification from any other recognized NLP organization and participated a 3-Day Language Excellence with Christina Hall or Dr. Doris (or any other ABNLP or SNLP 3-day Advanced Language Pattern training).

The other requirements include:

In general, NLP Master Trainers are expected to demonstrate the following levels of competency:

1. Engage in multi-level tasking, e.g., purposeful multi-level communication.
2. Detect the differences between the forms of conscious and unconscious mind communication
3. Make the distinction between content and the form of the content (process).
4. Integrate the NLP operational presuppositions into their thinking and behavior.
5. Know the difference between remedial and generative change.
6. Combine the various elements of the techniques to design customized interventions.

7. Build and utilize states of consciousness and physiology leading to greater flexibility, variability, creativity and mobility in thinking and in action.
8. Make conscious shifts in perspective, state and behavior (e.g., re-sequence habitual representational system sequences to interrupt “less-than-resourceful” states to keep open opportunities for discovery, creativity, learning and continued personal and professional development for themselves and others.
9. Utilize linguistic skills with purpose, e.g., use of language in ways that demonstrate “conversational intervention.”
10. Develop a greater awareness and utilization of a systemic approach.

1. Participation in the Master Trainer Training presented by Dr. Doris A. Greenwood or Christina Hall, Ph.D.
 2. **1,000 hours of conducting NLP training** after certification as a NLP Trainer awarded by Dr. Doris or Christina Hall, Ph.D. through the Society of NLP.
 - A) A minimum of **500 hours** of presenting **NLP Practitioner training** (beyond the 100- hour requirement for certification as NLP Trainer). (See list of criteria attached.)
 - B) A minimum of **500 hours** of presenting **NLP Master Practitioner level**. (See list of criteria attached. The NLP Master Practitioner requires 12 days minimum including the 8 Meta Programs with profiling. If required, a re-take of the 12-day CS Master Practitioner.
 3. **Re-take** of the 12-day Conscious Solutions & Society of **NLP Trainer Training** a minimum of one time (2 times).
 4. One **re-take** of Conscious Solutions **NLP Master Trainer Training**.
 5. 20 hours **Mentorship/Internship** on how to conduct Trainer Training.
 6. Conscious Solutions **trainer partnership** (You will be required to sign a **contract**.)
 7. **Written Test:** Description of the design of your Master Practitioner Training, including an analysis of the nested loops structure of your program design.
 8. **Video Project:** Your entire presentation on Meta-Programs (including exercise instructions and/or handouts) during the Master Practitioner training, using the “Nested Loops Staircase Model,” from introduction (setting frames) to the closing of the Meta Program presentation. This includes the entire presentation on video (excluding only the actual time during which the participants are doing the exercises).

9. Compliance with the rules of international copyright. If any inappropriate, unethical use and duplication of any materials is seen or reported to Conscious Solutions or The NLP Connection, the title of NLP Master Trainer certification will be revoked.
10. Certification procedures include the signing of a Certification and License Agreement and a certification fee of **USD \$220.00** after **all** NLP Master Trainer requirements have been submitted and approved.
